



Pre-cast base, grounding and ducting application process for Consultants

- In order to be approved as a consultant for this Pre-registered Customer Installed Duct Pad and Grounding (CIDPG) list you must submit an AFC site plan. This site plan must meet the requirements laid out in the FortisAlberta Inc. process. This AFC drawing may be a mock drawing. The key purpose is to show an understanding of the details required by FortisAlberta for these drawings. A cable pull calculation that compliments the AFC drawing, using Fortis Alberta's supplied Cable pulling analysis tool, must also be submitted. This AFC drawing and pull calculation will form part of the approval decision.
- **Applicable only for *Complex Services*:**
Cable pulling calculations are required from the customer/pre-registered design consultant if it considered *complex*.
- Please note that only *complex* services require Design consultants to complete and sign the AFC drawings.
